INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Traffic Stop - Verbal Warning	2019-04-01	Traffic Sop-Verbal warning - License plate light
Parking Complaint	2019-04-04	RP called to report cars were blocking the road. Officer arrived and observed two vehicles parked on Woolsey Lane. Officer made contact with the builder and the cars were moved immediately. RP was advised.
Public Assist	2019-04-04	Officer delivered Woodland Council packets.
Alarm - Residential	2019-04-08	Officers responded to a residential alarm, officers located an unsecured door that possibly blew open from the wind. Officers checked the residence and found nothing out of the ordinary. The homeowner's sister responded and updated the homeowner, an alarm report was left with the sister. A garage on the property was also checked and found secured.
Alarm-Residential	2019-04-08	Officer was dispatched to a residential alarm but cancelled by the alarm company prior to arrival.
Alarm-	2019-04-09	Officer responded to a residential alarm covering upper doors.

Residential		Officer found residence and front door secure. An alarm response card was left at the house.
Traffic Stop - Verbal Warning	2019-04-09	Traffic Stop - Verbal Warning for both brake lights out.
House Fire	2019-04-11	Officer dispatched to a house fire. Upon arrival there was heavy smoke coming from the residence. Wayzata FD and several assisting departments responded. Officer provided traffic control by closing Maplewood Rd to the public.
House Fire - Rekindle	2019-04-11	Officer dispatched to a rekindle at the previous house fire. Wayzata FD was responding routine as did officers. Officers were cleared by Wayzata Fire Chief.
Phone Call - Extra Patrol	2019-04-11	Wayzata Fire Chief requesting extra patrol of the listed address due to a fire and rekindle.
Damage to Property- Information	2019-04-12	Homeowner called to report damage done to his property. Officer found some slight damage to pavers in his driveway but the home owner has not returned any calls to verify if this was the damage he was reporting. The damage was caused by the owners hired snow plowers.
Traffic Complaint - Information	2019-04-17	RP called to report a vehicle sped past her while walking her dogs. RP was unwilling to sign a witness statement when asked. Officer checked the area but was unable to locate the vehicle.
Medical - Heart	2019-04-20	Officer was called to a medical involving an adult male who thought he may be having a heart related issue. Officer gathered information and cleared when HCMC medics arrived on scene.
Animal Complaint - Injured Owl	2019-04-23	Officer was dispatched to an injured owl unable to fly. Officer reached out to several wildlife organizations, none of whom would take the injured bird. Officer moved bird off the roadway and advised RP.
Alarm - Residential	2019-04-25	Officer was called to a residence for an alarm. Officer confirmed the house to be secured and left an alarm report on the front door.
Suspicious Activity	2019-04-30	A resident of Woodland called to report suspicious activity. Caller reports during the day the cats were let into the house from the garage and someone used the bathroom. The resident wasn't sure who did it but wanted the Police Department to be aware, they requested nothing further.
