INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Traffic Complaint - 3rd Degree DWI - Arrest	2020-02-01	Officer stopped the listed vehicle involved in a driving complaint and the driver showed signs of alcohol impairment. Further investigation led to a DWI arrest. The driver, 41 year old Jacqueline Rae Glaser, of Waconia, agreed to a breath test with a reported value of .19 BAC . The driver was booked at the Hennepin County Jail for DWI.
Traffic Stop - Verbal Warning	2020-02-02	Verbal Warning - License plate light.
Fire Alarm-Residential	2020-02-06	Officer dispatched to a residential fire alarm. Officer canceled before arrival.
Traffic Stop - Verbal Warning	2020-02-09	Traffic Stop - Verbal Warning for failure to yield to oncoming traffic on a left turn.
Traffic Stop - Verbal Warning	2020-02-11	Traffic Stop - Verbal Warning for snow covered hood, windshield and rear window.

Residential		Officer checked residence and found contractor on scene, false trip. Alarm report left on scene.
House Fire	2020-02-12	Officer was dispatched to a house fire at the listed residence. Officer arrived and found the garage fully involved and the fire rapidly growing. Numerous fire departments extinguished the fire while officer spoke with residents and anyone involved. Home is a total loss.
Phone Call	2020-02-13	Contractor called regarding traffic entering the driveway of the recent fire. Officer advised the driveway can be blocked just off Gale Rd. as long as residents were allowed to come and go.
Extra Patrol	2020-02-13	Wayzata Fire Chief asked that DPD check on the listed residence throughout the night as there were still hot spots located within the rubble. Officer documented any fire observed during the checks.
