An estate sale was located and there was a large amount of traffic, the RP with the damage was contacted. An officer later put no parking signs up near her property as well as at the entrance to Gale Road. The officer attempted to contact someone at the residence but the estate sale was over.
Missing Child - Found	2019-06- 01	An officer was flagged down by a motorist who advised that his daughter was missing and had previously seen an unfamiliar vehicle in the driveway. The father and officer returned to the home where another juvenile was alone. The officer who was assisted by Minnetonka Police began searching the exterior of the home and the interior, the daughter was found sleeping on the floor in her room.
