INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Parking Complaint	2019-05-02	RP called to report there was several property maintenance trucks parked illegally on Breezy Point Rd. Officer arrived and found the trucks. Officer located the workers and advised them to move the trucks immediately. The supervisor had all the trucks moved before the officer left the area.
AOA - Notification	2019-05-02	Officer dispatched to notify a resident his brother had passed away. Officer attempted to make contact but upon arrival found contractors onscene who said the subject was not home. Officer contacted the requesting agency and provided the most currant phone number. Officer was advised by the agency's supervisor, they would make contact.
Medical - Overdose	2019-05-04	Officer dispatched to an intentional drug overdose. Officer arrived on scene and met with an adult female who stated she consumed over 10 pills which included Oxycodone, Anti Depressants, and Anti Nausea medication. Officer asked the subject why she took the pills and she stated that her boyfriend had broken up with her. HCMC Paramedics arrived on scene and transported the patient to Methodist Hospital.
