Directed Patrol	2021-05-04	An officer conducted directed patrol of Breezy Point Road for speed, no violations observed.
Found Property	2021-05-04	Officer was dispatched to a found property call. Officer arrived at the residence and spoke to the reporting party who stated that he found an open box on his driveway, upon investigating what the open box was, the reporting party found a brand new iPhone 12 Max inside the box. Officer took custody of the box and did not observe any addresses on the box. Officer brought the box back to the Deephaven Police Department photographed the box, and the iPhone and uploaded the photos to this case under the media section. The nanny denied the male access to the house. When the reporting party got home to her residence the nanny informed the reporting party who then called the Deephaven Police Department. Officer advised the reporting party that we would document the incident and provide extra patrol to her neighborhood.

Noise Disturbance		2021-05-08	An unidentified text-to-911 message was sent to dispatch regarding a loud party in the listed area. Officer arrived and located the source of the noise, which was behind the 2805 Maplewood Cir. residence. Officer made contact with the juveniles and advised of the noise complaint and advised them to quiet down. The juveniles apologized and stated they would be more quiet. There was no evidence of drinking, drugs, or crimes occurring and they were at a private residence so the juveniles were not identified.
