INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Alarm - Residential	2018-10-11	An officer responded to a residential burglary alarm. The home was secure and nothing seemed suspicious.
Suspicious Vehicle	2018-10-12	Resident reported a car coming and going from neighborhood, and parking in front of her home. Officer determined it was a female visiting someone across the street from the RP.
Information - House Check	2018-10-13	An officer received information on a house check.
Suspicious Activity - Unfounded	2018-10-16	A resident reported seeing suspicious males in her yard via camera while she was at work. Officers checked the area and found no one matching the description, officer did locate phone books on door steps in the neighborhood, officer stopped individuals matching the description yesterday who were delivering phone books.
Damage to Property	2018-10-17	An officer responded to a report of damage to property. The reporting party showed the officer where a vehicle drove onto her yard and damaged a yard light and tree. Unknown Vehicle or driver.

Noise Complaint- Unfounded	2018-10-17	Reporting party called to report hearing something that sounded like a crash on Co Rd 101. Officer responded to the area and checked with Minnetonka Police Department. No accident was found.
Traffic Stop - Verbal Warning	2018-10-19	Verbal Warning - Speed
Ordinance Violation - Illegal Signage	2018-10-20	An officer removed an illegal sign from the right of way and placed it by the salt shed.
Animal Complaint - Lost Dog/ Found	2018-10-23	Caller reported her puppy "Teddy" has been missing since 1600 hours. The description matched a dog found in the area of McKenzie Pt. Rd And County Rd 101 earlier. The animal owner was given the reporting parties phone number to pick up the dog.
Animal Complaint- Dog at Large	2018-10-25	RP reported seeing a dog at large for the past week with no collar. The dog runs down Shavers Lane and into the woods. It doesn't respond to calls from people.
