Ordinance Violation - Illegal Signage	2019-10-01	Officer removed a dock removal sign from the right of way and placed it behind the salt shed.
Medical - Overdose	2019-10-04	Officer dispatched to a medical for an overdose in the backseat of a car. Officer arrived on scene and found the patient unconscious and breathing. Officer woke up the patient and removed the aerosol from the vehicle. HCMC Paramedics arrived on scene and evaluated the patient. HCMC Paramedics determined that the patient would be okay and did not need transport.

Phone Call- Littering	2019-10-15	Resident called with questions for an officer regarding alcohol bottles being littered near the residence as well as a home that had seemingly been under construction for a long period of time. Officer advised police were aware of the littering issues and had been unable to find the responsible party.

Parking Complaint	2019-10-24	Officer advised by Lt. Whiteside that a caller was reporting a contractor was parked in a bad spot on Maplewood Road. Officer responded and spoke to the driver who moved the vehicle right away.

Traffic Stop - No Action	2019-10-29	Officer on routine patrol conducted a traffic stop after RO came back with a gross misdemeanor warrant in Hennepin County. Driver was not registered owner.
Parking Complaint	2019-10-29	Officer spoke to landscape company regarding parking on the street while working. Company moved vehicles and will request a permit if they determined it was needed.
Pd Accident	2019-10-31	Garbage truck and a passenger vehicle ran into each other.
Noise Complaint- Construction	2019-10-31	RP called complaining construction was happening outside the allowed hours. Officer called the RP and advised via voicemail construction could continue until 1800 hours not 1700 hours.
