Suspicious Activity	2021-08-04	Officer dispatched to a suspicious activity. Officer arrived and checked the residence and found nothing out of the ordinary. Officer advised the homeowner, who said her driveway sensor was tripped then her doorbell rang but no one was there.
Parking Complaint - Verbal Warning	2021-08-04	PD received a parking complaint on Maplewood Circle East. Officer located several cars parked on the street and no City permit had been issued. As Officer was writing a citation, the drivers came out and moved cars onto the property they were working at. Verbal warning.
