INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Parking Complaint - Citation	2021-10-03	CSO issued a citation for a vehicle as it was parked on city streets within the City of Woodland.
Parking Complaint - Citation	2021-10-04	Parking Complaint - Citation for parking on Woodland City Streets
Animal Complaint - Sick Raccoon	2021-10-05	A resident called to report a sick raccoon at their home, an officer responded and disposed of the animal.
Alarm - Residential	2021-10-08	Officer was dispatched to an alarm at the listed address; called in by the homeowner. The homeowner silenced the alarm accidently and requested an officer respond to check the residence. Officer arrived and found everything to be secured. The wind likely opened an unsecured basement door causing the alarm to sound.
Driving Complaint	2021-10-09	RP complaint of a resident on next street driving too fast and his Porsche is very loud. Has been ongoing for several

		years. Officer was unable to determine where the subject lives.
Ordinance Violation - Illegal Signage	2021-10-09	CSO removed illegal signage from the listed location. The signage was later disposed of at the salt shed.
Subject Stop	2021-10-16	Officer located a male trying to hide behind a mailbox in front of the listed residence. Officer identified the adult male who was obviously intoxicated, but able to care for himself. Male stated he was at his friend's house and was now waiting to be picked up by his girlfriend. Officer did not observe any evidence of a crime and recommended that the male return to his friend's house until picked up. The male cooperated and returned to the residence.
Ordinance Violation - Unlicensed Tree Trimmer	2021-10-16	Officer and CSO were dispatched to the listed address for a report of a tree service cutting trees without a permit at the listed residence. Officer and CSO arrived and spoke with one of the workers at the listed house, who directed them to the tree service crew in the backyard. Officer and CSO spoke with the tree service employee who got in contact with the homeowner. Officer and CSO spoke with both individuals and explained the ordinance. The homeowner said she would be unable to present the permits due to her husband being in the hospital. Officer spoke with the tree service employee and explained to them how to become a licensed company through the City of Woodland. The tree service was allowed to clean up the cut down trees, but then cease their work until they received proper permits from the City of Woodland. The tree service employee was verbally warned. CSO called the listed reporting party and left a voicemail. The reporting party later called the CSO back. CSO advised them with the resolution.
Ordinance Violation - Illegal Signage - Unfounded	2021-10-17	CSO observed a presumed illegal sign in violation of City of Woodland Ordinance. CSO spoke with the homeowner, as the physical construction of the sign seemed to be very well put together; CSO did not want to seize the sign immediately, as it looked like the homeowner was home. When speaking with the homeowner, CSO was told that they were doing a remodel project.
Directed Patrol	2021-10-18	An officer conducted directed patrol on Breezy Point Road for speed, no violations observed.
Information- Animal Complaint - Dog	2021-10-20	An officer was dispatched to an animal complaint at listed address. Officer spoke to the complainant over the phone who stated she did not want us to make contact with the dog owner yet but wanted it on the record that the dog had come into her garage and barked/growled at her. The dog did not attack but she was nervous it might next time.

		Officer informed her to call in if it happens again.
House Check	2021-10-20	RP was emailed the vacation house check waiver and will return it with details of his itinerary.
Animal Complaint- Aggressive Dog- Verbal Warning	2021-10-22	RP called PD office to report her neighbor's dog keeps coming onto her property and barking aggressively at anyone outside. Officer spoke with the animal owner and advised they keep the invisible fence collars on their dogs to keep them home. Animal owner agreed to keep them on.
Animal Complaint - Dog at Large	2021-10-22	While driving on Breezy Point Road CSO saw a white and brown colored dog with a yellow collar cross the street, then walk up the road. CSO followed the dog to the listed address. CSO attempted to make contact at the residence and requested an Officer to assist. The residents of the home came out and stated the they were unable to locate the dog. Officer began to look through the area, and CSO and the residents looked around the property. CSO and one of the residents located the dog in the backyard of the listed address, as it had just come through the tree line from the neighboring property.
House Check	2021-10-24	CSO conducted a house check at the listed residence. CSO observed the plywood door to the pool mechanical room to be open. Nothing suspicious or out of the ordinary was observed.
Traffic Stop - Written Warning	2021-10-25	Traffic Stop - Written Warning for unsafe u-turn. Driver was traveling westbound on County Road 101 and pulled sideways across Breezy Point Road, u-turned at Breezy Point Road to go back eastbound on County Road 101.
Medical	2021-10-25	Officers were dispatched to a fall. Officers arrived on scene with Wayzata Fire and found the patient laying on the floor of his home. A lift assist was conducted by Wayzata Fire. HCMC arrived on scene and took supervision of the incident. The patient advised they would not be going to a hospital.
Wire Down	2021-10-28	Officer dispatched to a wire down on top of a vehicle with the driver still inside. Officer arrived and found the driver uninjured and the wire to be the phone and internet wire. Xcel arrived and verified the scene was safe and the driver could exit. Wayzata Fire assisted the driver with backing out and off Gale Rd. Officer advised Century Link through dispatch.
House Check	2021-10-29	CSO conducted a house check at the listed residence. Nothing suspicious or out of the ordinary was observed.
House Check	2021-10-30	CSO conducted a house check at the listed residence. Nothing suspicious or out of the ordinary was observed.
