INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Fire Alarm - Residential	2022-02-02	Officer responded to a residential fire alarm. Officer was cancelled prior to arrival as it was a false alarm.
Alarm - Residential - Canceled	2022-02-04	Officer dispatched to a residential alarm. Officer canceled before arrival.
Alarm - Residential	2022-02-05	Officer was dispatched to a residential alarm. Officer checked the exterior of the residence and found an open door. Officer and, Wayzata Police Officer 7214, checked the interior of the residence and did not anything suspicious or abnormal. Officer noticed the deadbolt on the door was not secured and the wind could have blown open the door. Homeowner was notified and alarm report was completed.
Road Condition	2022-02-13	An officer observed several areas in Woodland where the roads were slippery, the plow company was advised.
911 Hang Up	2022-02-19	Officer was dispatched to a 911 hang up in the area of Maple Hill Road and 101. I contacted the phone number provided and verified police services were not needed.
Alarm - Residential - Cancelled	2022-02-19	Officer was dispatched to a residential alarm and cancelled by Hennepin County Dispatch prior to arriving.

Traffic Stop - Verbal Warning	2022-02-20	Traffic Stop - Verbal Warning for expired registration and holding phone while engaged in phone call.
Alarm - Residential	2022-02-23	An officer was dispatched to a residential alarm in woodland, officer checked the perimeter of the home and found nothing out of the ordinary. An alarm report was left at the front door.
Medical	2022-02-23	Officer was dispatched to a medical for a female feeling ill and for a CO detector going off. Officer arrived on scene and observed that the house was empty and spoke to the reporting party. The reporting party stated that she was having trouble with her furnace and had someone check it out earlier in the day. HCMC Paramedics and Wayzata Fire Department arrived on scene. WFD informed me that there were levels of CO in the house and the reporting party was evaluated by HCMC Paramedics. The reporting party refused transportation and stated she would wait in her vehicle until CenterPoint energy and Wayzata Fire Department were able to fix the issue.
